Subject: Notification of the Feasibility Study on the Provision of Securities Brokerage Services

LTMH Public Company Limited (mai: LTMH) (the "Company") would like to inform the Stock Exchange of Thailand and investors that the management of WealthX Securities Company Limited ("WealthX"), a subsidiary of the Company, is currently conducting a study and considering the feasibility of expanding the scope of WealthX's securities business operations to cover the provision of securities brokerage services, in order to support the provision of comprehensive services within the ecosystem of the Group's WealthTech business

The purpose of the said study is to expand the business of WealthX to cover a wider range of investment products, to accommodate potential future changes in investment-related and tax-related regulations imposed by the government, as well as to support the sustainable growth of the Company's group over the long term. In this regard, WealthX will consider a low-cost business model that builds upon the existing operating systems and existing customer base within WealthX. Furthermore, in undertaking the foregoing, WealthX will conduct the study in parallel with the consideration and selection of potential business counterparties and/or business partners, in order to support the determination of an appropriate business model.

In undertaking the foregoing, the Company's group adheres to the principles of good corporate governance. Upon completion of the study, WealthX will present the results of the study to the Board of Directors' meeting of WealthX for consideration and approval, and in the event that the said matter falls under the criteria requiring approval from the Board of Directors' meeting and/or the shareholders' meeting of the Company, the Company will proceed in accordance with the relevant regulations and approval authorities. In addition, WealthX will duly obtain all licenses and/or approvals from the relevant regulatory authorities before taking any action in relation to the said business operation.
